AGREEMENT TO RULES OF ISTEM SUMMER PROGRAM

In order to make this program a success, it is vital that all students realize that standards of conduct must be understood and observed. Parents/guardians are requested to go over the following items with their child.

I/we agree to observe the following iSTEM Summer Program Rules:

- 1. Lanyard with ID and name badge along with camp t-shirt must be worn properly at all times, as required.
- 2. Students must never be alone outside of the classroom or residence hall buildings. Unless given permission otherwise, all students must stay with their assigned buildings/rooms and be supervised by their instructors, teaching assistants, resident assistants, or a member of the iSTEM staff.
- 3. Cell phone/electronic devices may only be used during the approved time of day to make a phone call home, if necessary. These devices will be turned off at all other times.
- 4. Respect the personal property of others at the iSTEM summer program.
- 5. Be respectful of UCF property and inform a staff member if anything is damaged.
- 6. Use of tobacco, alcohol, or illegal substances will not be tolerated. Any items found will be confiscated and the student will be sent home.
- 7. Possession of firearms or other weapons will not be tolerated. Any items found will be confiscated and the student will be sent home.
- 8. Observe the program schedule, including meal times and other activities.
- 9. Obey all campus rules for summer program attendees.
- 10. Cooperate with faculty, professionals, teachers, and group leaders at all times.
- 11. Participate in all classes and activities.
- 12. Stay safe and always follow directions.
- 13. Be polite and respectful to everyone.

- 1. Camper will review and abide by the following from UCF regarding COVID-19 before attending camp:

- 2. Camper will monitor their health for 10 days prior to camp.
 - a. The day prior to camp, camper will complete the UCF COVID-19 Symptom Self-Checker: <u>https://ucf.service-now.com/self_checker?id=public</u> and
 - b. Will forward the "Clear to be on Campus" email they receive via email to <u>stem@ucf.edu</u>.



3. Prior to their arrival at camp each day, camper will complete the UCF COVID-19 Symptom Self-Checker found at https://ucf.service-now.com/self-checker?id=public and will forward results to stem@ucf.edu. Any parent/guardian who plans to exit their car when dropping off their camper must also complete the UCF COVID-19 Self-Checker and present proof of clearance to be on campus to staff

at check-in. Campers who do not pass their self-checker will not be allowed to attend camp for the day and will contact <u>stem@ucf.edu</u> for next steps.

- 4. Camper will wear a mask at all times while on UCF property and will only remove it while actively eating. Parents/guardians dropping off or picking up a camper and not staying in their car must also wear a mask at all times.
- 5. If dropping off a camper, Parent/Guardian will not leave campus until camper has passed their temperature check and has been approved to be at camp for the day.
- 6. Camper will practice social distancing while on UCF property.
- 7. Camper will abide by all UCF COVID-19 Policies posted in buildings and assigned labs.
- 8. Should a camper be required to stay home and their participation not be able to be moved online, a prorated refund will be given for days missed. Each situation will be reviewed individually.
